## **Discount Funerals and Burials**

### **GENERAL PRICE LIST**

*These prices are effective as of March 1, 2019, but may be subject to change without notice*

The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

**Basic Services of the Funeral Director, Staff and Overhead:.....\$1,150**

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving of remains. The fee includes the following:

- Availability of our professional staff to respond to initial call and request for information/services 24 hours a day, 7 days a week, 365 days a year, including holidays.
- Initial shelter and care of remains to include placement of identification documents on the remains and placement in refrigeration.
- Arrangement conferences, either in person, by telephone conference, e-mail or online to include interviews and consultation with family members or other authorized agents during all phases of the arrangements to gather information necessary for the coordination and timely execution of all details involved in the services/ceremonies requested for the deceased.
- Coordinating plans with the various parties involved including celebrants, cemeteries, churches, clergy, crematories, fraternal organizations, military honor guards or any other parties involved to accomplish and provide the services/ceremonies requested for the deceased.
- Administrative assistance in the completion of necessary notices, authorizations, certificates and permits required for the services/ceremonies requested for the deceased.
- Overhead including utilities, facility maintenance, insurance and administrative expenses. These costs are associated with all the services we provide and are proportionately distributed among the various services to include the common areas such as the parking lot, reception areas, restrooms and office space. Overhead includes specialized funeral service equipment which is not seen by the public but necessary for us to provide services and requested.

**Embalming: \$650**

Except in certain special cases, embalming is not required by law. Embalming may be necessary,, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Embalming includes the professional care and preparation of the deceased for a public viewing and services. Our charges reflect the training and experience of our licensed professional staff and the time necessary for care and preparation. All procedures are in strict compliance with professional and OSHA guidelines, to protect staff and visitors. **It is the policy of our firm to require embalming for any public visitation or ceremony.**

**Other Preparation of the Body:**

Refrigeration: \$100

Florida Rules and Regulations requires that any human remains held 24 hours beyond death shall be embalmed or sealed in a container that will not allow fumes or odors to escape, or be kept under refrigeration, if this does not conflict with a religious belief or a medical examination. **It is the policy of our firm to comply with Florida Rules and Regulations that require the placement of human remains under refrigeration if held 24 hours beyond death if those remains have not been embalmed. After 10 days of refrigeration, an additional \$15 per day will be assessed after all required authorizations have been obtained.**

Dressing, casketing and cosmetizing, bathing and disinfection of deceased: \$85

We understand the importance of the appearance of your loved one to you, and are committed to being the very best in our profession. After embalming is completed, additional care and preparation includes dressing of the deceased, minor restoration, manicuring, and application of cosmetics by a licensed funeral practitioner. This preparation may also include restoration required as a result of trauma, extended illness, or disease.

Special care for autopsied cases or donor remains: \$50

**Use of Facilities and Staff Services:**

**Use of facilities and staff services for visitation at our facility or other facility.....\$185**  
(Includes setup of visitation area, placement of casket or urn, display of floral arrangements and personal memorabilia, supervision of proceedings, and attendance during the visitation)

**Use of facilities and staff services for funeral ceremony in other facility.....\$395**  
(Includes coordinating the funeral arrangements, placement of casket, display of floral arrangements and personal memorabilia, and supervision of the ceremony)

**Use of facilities and staff services for a memorial service in other facility.....\$395**  
(Includes coordination of the memorial service arrangements, placement of urn, display of floral arrangements and personal memorabilia and the supervision of the ceremony)

**Staff services and equipment for a graveside or cryptside service.....\$395**  
(Includes coordinating the graveside or cryptside service arrangements, placement of casket or urn, display of floral arrangements and personal memorabilia and the supervision of the graveside or cryptside service)

**Staff services for service at the Crematory.....\$395**  
(Includes accompaniment of the remains to crematory, supervision of service, display of floral arrangements and staff to assist with service.)

**Transportation/Automotive Equipment:**

**Transfer of Deceased from place of death to the Funeral Home  
(Within a 50 mile radius).....\$95**  
Additional Mileage will be charges at the rate of \$2.85 per mile.

This fee is for the initial transfer from the place of death to the funeral home. It represents the time required for qualified personnel to make the transfer from the place of death. It also includes the vehicle used for the transfer and the necessary equipment to comply with safety and health regulations.

**Funeral vehicle, hearse (within a 35-mile radius and up to three hours).....\$195**  
Additional distance will be charge at \$2.85 per mile/Additional hours will be charged and a rate of \$50 per hour.

Transfer to or from Orlando International Airport: \$145  
(Additional distance will be charged at \$3.35 per mile.)  
Transfer to Daytona International Airport: \$50  
Transfer to Shands Hospital - Gainesville: \$295

**Forwarding Remains to another Funeral Home.....\$1,650**

This fee for our charges includes a proportionate share of the basic services of the funeral director, staff and overhead; embalming; transportation/automotive equipment to include the initial transfer of remains from place of death to the funeral home and transportation to local airport or other place of shipment within a 35-mile radius and required shipping container (excludes airline shipping charges). The charge does not include visitation or ceremonies and applies only to shipment within the continental United States.

**Receiving Remains from another Funeral Home.....\$1,150**

The fee for our charges includes a proportionate share of the basic services of the funeral director, staff and overhead; transportation from local airport or other shipping destination (within a 50-mile radius), and service vehicle for local transportation of remains to cemetery or crematory. The charges does not include visitation or ceremonies.

**Direct Cremation: \$979 - \$989**

If you wish to arrange a direct cremation, an alternative container can be used. Alternative containers encase the body and can be made of materials such as fiberboard or composition materials (with or without an outside covering). The containers we provide are made of cardboard.

The fee for our charges for a direct cremation (without ceremony) includes a proportionate share of the basic services of the funeral director, staff and overhead; other preparation of the body to include the placement of the body under refrigeration; transportation and automotive equipment to include the initial transfer from place of death to the funeral home,, and the use of our onsite crematory.

- Direct cremation with container provided by the purchaser. (All containers must meet all applicable state or crematory requirements).....\$979
- Direct cremation with casket from our facility (in addition to cost of casket).....\$989

- Direct cremation with a cardboard alternative container. No interior.....\$989
- ID View by 2 people at Crematory through witness cremation window (without feature preparation, 15 min).....\$ N/C

**Immediate Burial: \$1,150 - \$2,335**

This fee for our charges for immediate burial (without any ceremonies at the funeral home, graveside or elsewhere) includes a proportionate share of the basic services of the funeral director, staff and overhead: other preparation of the body to include the placement of the body under refrigeration (controlled temperature); transportation and automotive equipment to include the initial transfer from the place of death to the funeral home and use of service vehicle for local transportation to cemetery.

- Immediate burial, with container, provided by the purchaser (containers must meet any applicable cemetery requirements).....\$1,150
- Immediate burial with casket from our facility.....\$1,150  
(In addition to cost of casket - see Casket Price List for prices)
- Immediate burial with minimum casket from our facility.....\$2,335
